Regular District Meeting Minutes Sunday October 22, 2023 – 1:00PM

Quorum established by District Chairperson Myrna Thompson, meeting called to order at 1 PM.

Opening prayer given by Avina Hayes.

Motion#1: Made by Katy Hill to adopt agenda, 2nd by Lita German, ? Phoenix Ironheart, MVC.

Chairperson Myrna Thompson set ground rules to be respectful and that we need to keep order, if we disagree please be respectful and all of your voices are important. There are a lot of members here please allow people to finish sentence and raise your hands and you will be called upon in order noted. And we want to have a good meeting today. Allowed members to get plates as the food is ready and we will start the meeting in 15 minutes.

Danielle DeCoteau, Treasurers Report:

Danielle DeCoteau, Treasurer pulled up September and October on quick books, power point presentation. Showing an accurate update of activity worksheet for September and October for which she was here. Also has a breakdown of each category, shows balance of \$20,015.32. Going over reports. Sharing that the elder lady Sylvia Deutsch & her son, Jason Deutsch, Sisseton Courier, being threatened by Susie "Lydia" Amos and her son, Joseph Herman Jr., and how terrified they were being threatened with the FBI showing up on their doorsteps. They said Suzy reported she's on Tribal Council and that she had one year left & shared she had a heart problem. Audio was played of this. Danielle stated they are living in fear now and they did not deserve this as they were following their office rules. Danielle went over her cover reconciliation sheets, although some months had some overdrafts not all of them did as was shown on her sheets. Danielle reminded people that Lynn was the one in office at that time and made a double bank payment without a district motion in turn which caused a ripple effect. Danielle reported that all of what Suzy Amos tried to copy are financials that

belong to Big Coulee District and are not the property of Suzy Amos as she and her son Joseph Herman Jr. stated. Danielle also reported there were NO voided checks as being reported on the statement, the Bank President Kelly Hanson confirmed this. Suzy Amos' Bank Reconciliation stated BCD had a \$41,806.51 overdraft in March; however, the Bank President confirmed it was -0overdraft; Suzy Amos bank reconciliation showed that in April, BCD had a \$23,120.62 overdraft; however, the bank president confirmed it was \$7,527.04; Suzy Amos' bank reconciliation statement showed that in May, BCD had an overdraft of \$4,563.84, but bank president confirmed \$3,593.00, but stated both were only for a few days. This was the snowball effect from the unauthorized double phone payment made by Lynn Halbert. And also the Housing Development savings deposit being paid in bulk; one payment for \$44,000 and one for \$12,500 in February. Danielle DeCoteau felt that this was to discredit the new executives because these actions put them at a disadvantage from the beginning. Danielle showed the district copies of checks that were written by previous executives; no application or district approval for Home Repair for Suzy Amos' grandson but it was paid to a mortgage company of \$5,000 which is not in the home repair policy, one signature on check signed by Lynn for Suzy, Suzy writing as well as signing her own elderly checks (\$2500 & \$1500) and 3 college graduation checks written to Lynn Halbert, her daughter and Suzy Amos grandson in the amount of \$500 each, all signed by Lydia Rivera and Lynn Halbert, and again it's not in our education policy. Again, a check to Lydia Rivera to over \$671.00 for office supplies reimbursement, with one check signature, Lynn Halbert; \$1,020 to Susie Rivera for reimbursement for computer and chair, where is the receipt and where are they? Where are the motions? She said these should have all followed district policies. Danielle DeCoteau brought up the original motion where Susie requested \$30,000 for audit that was defeated in 2019 as you cannot audit yourself; and, she showed the checks as she got a second motion that got approved a month later, this time for \$25,000 for an audit. DCA report to Tribal Council on October 3rd, Myrna requested Danielle (Sgt at Arms) to go with her to Susie's office (as a silent witness) to retrieve the USB with "audit" aka compilations for Big Coulee District, 2013 through 2017. Susie stated she had it at the August 31st regular district meeting; Motion #19 was made then that she return the USB/flashdrive as it is district property due to the district paid her \$25,000 for it. But Susie did not provide it the next day, September 1st as she stated she would. She did not give it to the District Chairperson when she went to get it and still hasn't provided it. Danielle asked for questions.

Lisa Jackson had a question and asked Danielle what you currently have on Quickbooks you will always have our applications and back up uploaded right? And Danielle stated yes, they are scanned and uploaded.

Myrna Thompson, Chairperson, stated that the deadline is November 15th – and she will do all she can to assist everyone. She asked Susie Amos where are all the documents; she admitted she has documents from 2018. She said she took this to the Feds and tried to get someone indicted but they did not take the case so she still has the records. Danielle DeCoteau asked her why does she feel the right to keep Big Coulee District documents? Susie stated she felt they didn't give her the time to do it. Lisa asked her when she would get it over here and Suzy stated she will get them to the district tomorrow (10/23/2023). Myrna stated that we were told that Susie Amos has the home repair binder. Danielle DeCoteau stated that past executives should have passed everything over in a good, organized, responsible way; not just say they were thrown in some totes somewhere. Lisa recalled helping hauling totes to the back room in the past but where are they?

Lisa Jackson said, there are several tracks here there is Personnel, Council Removal, Council and our District removal. Lisa stated the District has their own authority to handle this. LeeAnn Tallbear

spoke and said in a perfect world it would work as such but we all know how Tribal politics work. how Brandon Adams was removed for being on social media and speaking up inappropriately and ended up resigning. LeeAnn feels that there should be criminal charges filed and especially for that mortgage payment. Suzy stated she can create another jump drive from her computer. She said there was one in a ziplock bag left here. Geri Opsal spoke and said that were only trying to do what is right, we are showing transparency, we are staying off Facebook, we are trying to get back on track and bring everything to light and we will try and help everyone find what they need for audit and we hope and recommend that you all keep copies, we want to have a great district and we are trying to do what is right, we are trying to get everything operational and follow all the motions that the district gives us, also remember God knows all, sees all, he knows when someone is lying. Let's be truthful and work together. Gerald German stated that Suzy Amos has no right keeping district documents at her home. Big Coulee District paid for these and they should be maintained here at the District center. We need to follow the Constitution and By Laws. LeeAnn Tallbear stated that we need to keep all of our business in the District, get work center pro in the budget, now that Danielle DeCoteau is uploading all documents and applications we should not go through this again. If Suzy Amos was using Quickbooks as they stated publicly at district meetings, then all the applications should be uploaded on the Quickbooks they were using. Avina Hayes spoke and said everyone needs to make copies, she asked why are they hiding them? It's not fair to the members, she stated that those that have everything need to bring them and work together, that Jesus sees what everyone is doing, that we need to work together and she reminded everyone they will be judged for their own wrongdoings. Katy Hill spoke and she wanted to remind everyone of Joe Herman and Suzy Amos' behavior and using district documents falsely. Katy Hill asked Suzy Amos and Joseph Herman why were they impersonating, getting district copies? Katy reminded that our Constitution states, "We the People".......... They need to be held accountable for this. And she wants to make a motion.

MOTION #2: Made by Katy Hill that Susie Amos, Councilperson resign or we will go through the recall petition process for removal according to the Constitution, 2nd by Dawn Godfrey,? by Nolita Hill. 36 voted for 13 voted against, MVC.

Kristin Renville German stated that the resignation should be immediate or at least requested an answer by the end of the meeting. Victoria Dubois asked who will take council position, it was answered it will be an Interim, we will recommend to Tribal Council, then an election, if that's the case.

MOTION #3: Made by LeeAnn Tallbear upon completion of audit, any findings, to prosecute federally, 2nd by Dawn Godfrey,? by Katy Hill, 33 for, 2 opposed, MVC

It was recommended to go to the Northern division, as Susie Amos has reported she is an informant for the Federal agents in SD.

MOTION # 4: made by Liz Hill to approve Treasurer's report, 2nd by Nadine Fredericks,? by Nolita Hill, MVC.

Councilperson report by Susie Amos for the following dates:

Reported the Tribe is giving the district unused ARPA funds of \$123,600.00 pending a plan of what it would used for. Danielle asked if there are policies of how to be used, economic development? She responded yes, that just no membership disbursements. Ella had a question about the \$150,000 economic development. At this point LeeAnn Tallbear asked Danielle DeCoteau if we don't have a clean audit for one year and its looking like we won't, that we will not be eligible for any grants that she could write for our District. Danielle DeCoteau said if they don't turn over the books, home repair, all applications, we won't have a clean audit. Gerald German had a question about hav being hauled by Langauger - asked Suzy about BIA leasing policy. Several district members can haul hay; we have Ronnie Nieland, his son Ronnie Jr. and himself, that all haul hav, that's 3 district members. In 2022, the tribe gave \$150,000 of all the business to a non-Indian. The district membership is never reported or notified to bid on. He asked our Councilperson Suzy Amos why? She didn't have an answer. The Tribe is also going to look to California to provide product for dispensaries. Suzy stated that when it was discussed she was on medical leave so she has no idea. He also asked how she would support our district members? Suzy, will you advocate for the district members? - she said no one will come to her office. Gerald German asked her to represent her district members and advocate for them. He said that Indian preference has always been a policy of the Tribe, he's wondering why its not being followed. Susie Amos told Gerald that he should ask his brother (Tero Director), Gerald stated Tero Delray German is his cousin. LeeAnn Tallbear stated that the first words out of her (Susie's) mouth should have been, "Is there a Indian Business" first and foremost! She stated that the oath is not being followed, to always ask "is there an Indian company?" That should be the first and foremost question asked by our District representation. Danielle DeCoteau stated the Indian Preference should always be followed, and as a Council person she should always look out for the membership. She also stated that a district member said that he went to Susie Amos, our Councilperson, she did not speak on his behalf of an issue at DMC. This person that was an employee of DMC for 9 years and he ended up resigning. A council person should stand up or the voice of the people. Suzy responded and said that it was handled in executive meeting. Danielle stated the employee had already resigned by then as he did not get any help. Lisa Jackson asked Gerald if he contacted Tero, yes he called Delray and was asked how is TERO being enforced. Tribal Council doesn't follow Tero, it's oppression and not following Tribal law. CRP acres were given to the white people, they are given notice before the Indian. Gerald asked about a report from Ella about the CRP acres. Why are the Tribal members being notified a week after the white guys?

MOTION #5: by Lisa Jackson that Tribal Realty will identify an opening date to begin to receive CRP land to include hay & land after giving our tribal membership adequate opportunity to bid before they give the opening, 2nd by Gerald German, ? by Megan Cook, MVC

MOTION #6: made by Danielle DeCoteau for Council rescind the Motion #24 (10/23/23) giving Langauger the bid contract for hauling hay and bid it out to our Tribal members that haul hay. BCD has 3 district members that haul hay, 2nd by Nadine Fredericks? by Dawn Godfrey, MVC.

MOTION #7: made by Lisa Jackson to amend the portion of the TERO ordinance 59-02-07 to change the language so the Tribal Government is a covered employer, to remove exemption from not following TERO LAW and that it requires Tribal Government follow Indian

preference (TERO) in all contracts and services paid for with Tribal and ALL other government funds. Include that it goes through DCA in Motion to bring to Council., 2nd by Leanne Tallbear, ? by Wayne German, MVC

MOTION #8: Viva Dubois to approve Council person report, 2nd by Lisa Jackson? Luann Phelps by MVC.

Chairperson report by Myrna Thompson:

Gave an updated District Operations report, also brought up the libel comments on FB and social media, that she will file a federal tort claim if this continues to happen. She reported that Danielle DeCoteau has received the password for our District Web page paid for to Ross Kahrahrah and we will be utilizing that for District information and business.

Motion #9: by Carrie Godfrey to approve Regular District Meeting from September 28, 2023 and Executive Meeting Minutes October 3rd, 2023 and October 13, 2023, 2nd by Dawn Godfrey, ? by Samantha Dumarce, MVC.
